

## **#CCGwithMe Hat Photo Contest**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who upload photos to social media using the #CCGwithMe hashtag or email photos to [media@coreycgriffinfoundation.org](mailto:media@coreycgriffinfoundation.org) and who are 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of the United States and is void where prohibited by law. Employees of the Corey C. Griffin Foundation], its affiliates, subsidiaries, advertising and promotion agencies, directors and suppliers, (collectively the “Employees”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

How to Enter: The Campaign must be entered by submitting a photo on Facebook, Twitter or Instagram using the hashtag #CCGwithMe, or by emailing a photo to [media@coreycgriffinfoundation.org](mailto:media@coreycgriffinfoundation.org). The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Corey C. Griffin Foundation.

5. Prizes: The Winner(s) of the Campaign (the “Winner”) will receive one free ticket to CoreyFest 2019 or the 2019 Boston Winter Ball. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by the Corey C. Griffin Foundation. No cash or other prize substitution shall be permitted except at the discretion of the Corey C. Griffin Foundation. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for the Corey C. Griffin Foundation to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

7. Winner Selection and Notification: Winner will be selected by a vote by designated committee of the Corey C. Griffin Foundation Board. Winner will be notified by email and/or a post/message on social media within five (5) days following selection of Winner. The Corey C. Griffin Foundation shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 10 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is

By entering this content, You represent and warrant that your entry is an original work of authorship, and does not violate any third party's proprietary or intellectual property rights. Griffin Foundation may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the Corey C. Griffin Foundation. The Corey C. Griffin Foundation reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions. The Corey C. Griffin Foundation has the right, in its sole discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
